Location: land owner in the Bullpasture Valley; located near head of stream near Doe Hill about 1750.<sup>1</sup> Military: between 1754 and 1763 Sergeant in French and Indian War.<sup>2</sup> Property: in 1759 settled one mile south of Doe Hill, VA.<sup>2–3</sup> **Robert ARMSTRONG**<sup>3–4</sup> was born in Ireland.<sup>5</sup>

Robert ARMSTRONG and Jane VAN ARSDALE were married in 1746.<sup>2</sup> Location: in Venordsdale .<sup>2</sup> **Jane VAN ARSDALE**<sup>6</sup> was born (date unknown).

Robert ARMSTRONG and Jane VAN ARSDALE had the following children:

- 4. **John ARMSTRONG**<sup>3,18–21</sup> (Robert-1) was born in 1759.<sup>22</sup> Location: came to Doe Hill, VA from Loudoun County, VA in 1794.<sup>23–24</sup> Property: on 10 Sep 1816 purchased 50 acres from William Blagg for \$100 in Pendleton County, VA.<sup>25</sup> Illness: weak in body in Jun 1820.<sup>20</sup> He signed a will on 9 Jun 1820 in Pendleton County, VA.<sup>20</sup> He died about 1821; at the age of 62.<sup>3,23,26</sup> Individual Note: on Pendleton County Grand Jury.<sup>27</sup> Military: Revolutionary War soldier.<sup>23</sup>

John ARMSTRONG and Agnes "Nancy" ERVINE were married in 1779.<sup>28</sup> **Agnes "Nancy" ERVINE**<sup>17,29–33</sup>, daughter of Jared ERVINE and Elizabeth , was born in 1764.<sup>28</sup> She died in 1827; at the age of 63.<sup>23</sup>
