1. Location: in Augusta County, VA Came from North Carolina and settled on the Calfpasture, (Augusta) Highland County, VA in 1744.¹⁻² Property: Bought 544 acres on the Calfpasture from James Patton and John Lewis on 17 Jul 1744.¹⁻³ Military: in 1758 Member of Capt. William Preston's company of Rangers.⁴ Property: sold 241 acres (of a tract of 544 acres) on the Calfpasture River to son Robert for five shillings on 18 May 1762 in Augusta County, VA.⁵ **Robert GWIN**^{3-4,6} was born in Wales.²

Location: in Albemarle County, VA .¹⁻² Individual Note: Had 9 children .¹ **Jean KINCAID**¹ was born (date unknown).

3. Location: Lower Cowpasture; from Augusta County, VA in 1781.¹⁰ **Joseph GWIN**^{7,11-12} (Robert-1) died in 1817; .⁹ Property: Owned 42.6 acres valued at \$100 in 1862.¹³

4. **David GWIN**^{2-4,7,16} (Robert-1) was born in 1742 in Wales.^{2-3,17} Location: Jackson's River, 1 mile from Bath County line in 1780.¹⁸ Property: Purchased the farm of John Peoples, Sr., Bullpasture, Highland County, VA in 1805.^{2,19-20} He died in 1822; at the age of 80.^{3,17} He was buried in 1822 in Clover Creek Presbyterian Church Cemetery, Highland County, VA.^{17,21} Military: Officer (Captain and LT) in colonial wars.^{3,21-22} Military: Commanded a company at the Battle of Guilford Court House.^{1,4} Estate: Gave Tomahawk Ranch to grandson, David Gwin.²³

David GWIN and Jane CARLILE were married in 1768.¹⁻² **Jane CARLILE**^{2,24-25}, daughter of James CARLILE and Nancy CAMPBELL, was born in 1746.²⁶ She died in 1787; at the age of 41.¹ Location: in Kentucky about 1805.²⁷ Individual Note: Had 9 children.¹ She was buried at off county route 611 in Jackson's River area, Highland County, VA.²⁶

David GWIN and Jane CARLILE had the following children:
