1. **William BLAGG**¹⁻⁵ was born on 8 Mar 1740.^{3,6} Property: owned 283 acres lying on Mecham's River; purchased for 25 pounds Virginia currency in Albemarle County, VA between 1772 and 1777.⁷ Property: paid 25 pounds to William Smith for 283 acres in Albemarle County, VA on 10 Sep 1772.⁸ Property: sold 283 acres to William Smith in Albemarle County, VA on 13 Nov 1777.⁹ Individual Note: Purchased some of Joseph Gamble's estate, as did Moses Knapp between 1780 and 1782.¹⁰ Location: in Doe Hill area, VA 1 mile NW in 1780.¹¹ Location: in Doe Hill area, VA Moved to Doe Hill, VA from Albemarle County, VA about 1781.¹² Property: Survey of 81 acres in Augusta County on the head of the west branch of the Bullpasture in 1782.¹³ Property: Survey of 86 acres in Augusta County on a west branch of the Bullpasture river in 1786.¹⁴ Property: Survey of 50 acres in Pendleton County lying near the head of Bullpasture in 1796.¹⁵ Property: Survey of 100 acres in Pendleton County on west branch of the Bullpasture in 1800.¹⁶ Property: land patent for 100 acres on the Bullpasture in Pendleton County, VA on 6 Sep 1802.¹⁷⁻¹⁸ Property: Survey of 30 acres in Pendleton County in 1804.¹⁹ He signed a will on 14 Feb 1809 in Pendleton County, VA.⁴ Property: sold 50 acres to John Armstrong for \$100 in Pendleton County, VA on 10 Sep 1817.²⁰ He died on 13 Jan 1820; at the age of 79.^{3,6} Estate: in 1847 45, 50, and 50 acres lying in part of Pendleton County, VA that became Highland County, VA.²¹ Individual Note: On Pendleton County Grand Jury.²² Family Note: efforts to link pioneers William Blagg and Caleb Blagg genetically via DNA testing failed. Two male descendants of Caleb and two male descendants of William had Y-DNA testing performed. The two descendants of William, James Abner and Gary Stuart Blagg agreed on 34 of the 39 alleles tested that were common to both. The two Caleb descendants agreed entirely with each other for all their 37 alleles tested, but only agreed with 17 of the 37 tested that were common to both of William's male descendants.²³

William BLAGG and Elizabeth Jane WILSON were married in 1773. **Elizabeth Jane WILSON**^{1,3,24-25}, daughter of William WILSON and Mary, was born on 26 Sep 1752.^{3,26-27} She died on 17 Jan 1808; at the age of 55.^{3,27}

3. **John BLAGG Sr.**^{3-4,6,31-37} (William-1) was born on 9 Jun 1778 in Virginia.^{3,33,38-42} Property: bought tracts of land of 227 & 50 acres from Moses Knapp for \$800 in Pendleton County, VA on 21 Sep 1816.⁴³ Tithable: Pendleton County, later to become Highland County, VA in 1822.⁴⁴ Property: survey for 120 acres in Pendleton County lying on the waters of the Bullpasture River in 1831.⁴⁵ Property: with brother James sold 80 acres to Benjamin McCoy for \$320 in Pendleton County, VA on 3 Nov 1835.⁴⁶ Property: 50, 227, and 40 acres lying in part of Pendleton County, VA that became Highland County, VA in 1847.²¹ Property: owned 7 horses and 1 clock in 1847.²¹ Occupation: Farmer between 1850 and 1860.^{32,47} Property: Owned real estate valued at \$2,000 in 1850.³² He signed a will on 19 Apr 1856 in Highland County, VA.⁴⁸ Property: sold 80 acres of Moses Knapp land and 20 acres of 40 acre patent to Eli H. Wilson for \$200 in Highland County, VA on 6 Jul 1858.⁴⁹ Property: owned personal estate valued at \$1,193 in 1860.⁴⁷ Property: owned real estate valued at \$2,313 in 1860.⁴⁷ Property: 217 acres valued at \$1,533 in 1862.⁵⁰ He was buried in 1862 in Chestnut Hill Cemetery, Blagg Farm, Doe Hill, VA.³⁸ Agriculture: in 1862 owned 9 cattle, horses, or mules valued at \$219.⁵⁰ Cash on Hand: \$35 in 1862.⁵⁰ John died on 20 Nov 1862; at the age of 84 Smallpox in Doe Hill, VA.^{38,51-52} Estate: in May 1866 in Highland County, VA estate settlement; 185 A to James H., 183 A to Samuel's heirs, and 136 A to John's heirs.⁵³ Estate: on 24 May 1870 in Monterey, Highland County, VA Chancery Court ordered that son James was to pay \$80, with interest compounded, to settle the sale of land made in 1855.⁵⁴
