Property: purchased land from Thomas Parsons on the South Branch in 1765.<sup>1</sup> Location: in Pendleton County, VA South Branch, at Pendleton County line in 1765.<sup>2</sup> Property: survey for 93 acres on South Branch, Pendleton County, VA near Nicholas Harper in Pendleton County, VA in 1772.<sup>3</sup> Property: owns 2 horses and 3 cattle in Augusta County, VA in 1787.<sup>4</sup> **Peter FLEISHER**<sup>4-6</sup> died in 1801; .<sup>7</sup>

**Anna THIEL**<sup>8</sup> was born (date unknown).

4. **Sophia FLEISHER**<sup>7,11</sup> (Peter-1) was born (date unknown).

Sophia FLEISHER and Philip ECKARD were married in 1799.<sup>7,11</sup> **Philip ECKARD**<sup>7,11-13</sup>, son of Philip ECKARD, signed a will on 5 Mar 1816 in Pendleton County, VA.<sup>13</sup> He died about 1820; .<sup>11</sup> Location: in Pendleton County, WV Lived at Jacob Eckart's, 3 miles above Sugar Grove .<sup>11</sup> Property: willed brother Abraham's plantation where he lived in Pendleton County, VA.<sup>12</sup> Family Note: had daughters, but not named in will .<sup>13</sup>

5. **William FLEISHER**<sup>7</sup> (Peter-1) was born (date unknown).

William FLEISHER and Margaret ECKARD were married in 1781.<sup>7</sup> **Margaret ECKARD**<sup>7</sup> was born (date unknown).

6. Property: owns 6 horses and 10 cattle in Augusta County, VA in 1787.<sup>4</sup> **Conrad FLEISHER**<sup>4,6-7,14</sup> (Peter-1) died in 1797; .<sup>7</sup> Family Note: in Aug 1797 had 2 daughters, not named .<sup>10</sup> He signed a will on 21 Aug 1797 in Pendleton

County, VA.<sup>10</sup> Illness: very sick and weak in body on 21 Aug 1797.<sup>10</sup> Estate: on 16 Oct 1797 in Pendleton County, VA appraisal including shoemaker tools valued at 155.6.3 pounds .<sup>15</sup> Location: in Crabbottom, Highland County, VA .<sup>7</sup> Estate: valued at \$517.71 .<sup>7</sup>

Conrad FLEISHER and Sophia Catherine were married.<sup>14</sup> **Sophia Catherine**<sup>16-18</sup> was born (date unknown).

Conrad FLEISHER and Sophia Catherine had the following children:

- +14 i. **Mary Elizabeth FLEISHER**, born 1784, Virginia; married Christian RULEMAN, 1799.

8. **Elizabeth FLEISHER**<sup>6,19</sup> (Peter-1) was born (date unknown).

Elizabeth FLEISHER and Martin LIFE were married in 1799.<sup>20</sup> Property: 98 acres from Catharine Waggoner for 70 pounds in Crabbottom area, Pendleton County, VA on 4 Oct 1803.<sup>21</sup> Location: in Lewis County, WV about 1810.<sup>22</sup> **Martin LIFE**<sup>19</sup>, son of Martin LIFE and Anna LANTZ, died about 1844; .<sup>22</sup>

9. **John FLEISHER**<sup>6,23</sup> (Peter-1) was born in 1755.<sup>7</sup> He died in 1779; at the age of 24.<sup>7</sup>

**Mary S.**<sup>7</sup> was born (date unknown).

John FLEISHER and Mary S. had the following children:

- 16 i. **Elizabeth FLEISHER**<sup>6-7</sup> was born (date unknown).
- +17 ii. **Henry FLEISHER**, born 1777, Pendleton County, VA; married Hannah Christina JONES, 9 Mar 1817, Pendleton County, VA; married Mary ZICKAFOOSE, 1803; married Christena WAGGONER, 1838; died 1852.

10. **Henry FLEISHER Sr.**<sup>4,6,9,24-26</sup> (Peter-1) was born in 1758.<sup>8</sup> Property: owns 4 horses and 8 cattle in Augusta County, VA in 1787.<sup>4</sup> Property: Pendleton County land patent for 65 acres on South Branch in 1797.<sup>27</sup> Property: 26 acres to Nicholas Harper for 10 pounds in South Branch, Pendleton County, VA on 1 Oct 1799.<sup>28</sup> Property: 200 acres from William and Elizabeth McCoy for 72.10 pounds in Strait Creek area, Highland County, VA on 7 Oct 1801.<sup>25</sup> He died in 1821; at the age of 63.<sup>8</sup> Tithable: Pendleton County, later to become Highland County, VA in 1822 .<sup>29</sup> Property: owned land on South Branch bottom 2 miles up from line of Pendleton.<sup>30</sup> Military: Sergeant in Augusta Militia, then 2nd Lieutenant under Captain McCoy in October 1788, then Major in Pendleton County Militia in December 1788 in Pendleton County, VA.<sup>31</sup>

Henry FLEISHER Sr. and Catherine PENINGER were married in 1778.<sup>8</sup> **Catherine PENINGER**<sup>9,24,26,32</sup>, daughter of Henry PENINGER, was born in 1762.<sup>8</sup> She died in 1821; at the age of 59.<sup>33-34</sup> Location: in Pendleton County, WV .<sup>7</sup>
