CURRY and John SHARP were married on 30 Sep 1797 in Augusta County, VA.^{3,17} **John SHARP**^{1-2,17,51-52} was born about 1772 in Pennsylvania.⁵³⁻⁵⁵ Agriculture: in 1850 200 acres improved, 700 acres unimproved land; farm value \$7,000, machinery value \$35, livestock value \$1,305 in Highland County, VA.⁵⁶ Occupation: Farmer between 1850 and 1866.^{46,57-58} Property: Owned real estate valued at \$7,000 in 1850.⁴⁶ Property: Owned personal estate valued at \$561 in 1860.⁵⁷ Property: Owned real estate valued at \$10,000 in 1860.⁵⁷ He died on 25 Jul 1866; at the age of 94 in Highland County, VA.⁵⁸
