1. **John HINER**¹⁻⁹ was born on 14 Sep 1742 in Leipzig, Germany.^{6,8,10-14} Location: in Pennsylvania with brothers Alexander and Harmon in 1770.⁸ He immigrated in 1772 to Pennsylvania.¹⁵⁻¹⁶ Property: homestead purchased; remained in Hiner family until 1968 when purchased by Delbert Rexrode, Jr. in Doe Hill area, VA in 1774.^{2,17} Location: moved from Shenandoah Valley to NE of Doe Hill, VA, near what later became Pendleton County line in 1776.^{7,18-20} Property: owns 7 horses and 13 cattle in Augusta County, VA in 1787.²¹ Property: land patent for 600 acres on Bullpasture in Pendleton County, VA in 1804.²² He signed a will on 12 Jul 1813 in Pendleton County, VA.⁴ John died in Dec 1814; at the age of 72.²³⁻²⁷ Military: Member of Capt. John McCoy's Augusta County, Virginia Militia.²⁸ Occupation: Wheelwright .²⁹ He was buried in Hiner Family Cemetery, Doe Hill area, Highland County, VA.³⁰⁻³¹

John HINER and Magdalene BURNER were married on 29 May 1774 in Shenandoah County, VA.^{7,9,32-34} **Magdalene BURNER**^{2,7,9,35-36}, daughter of Earhart BURNER and Magdalena Anna BUMGARDNER, was born in 1735.³⁷ She died in 1802; at the age of 67.³⁷ Location: in Shenandoah County, VA .²⁹

3. **Jacob HINER**^{1,4,60-63} (John-1) was born on 5 Sep 1776 in Virginia.^{1,64-66} Military: in 1794 on muster rolls of Capt Robert McCoy's Company in Pendleton County, VA.⁶⁷ Property: room in his house used as a jail for the confinement of debtors of Highland County, VA in 1847.⁶⁸ Occupation: farmer in Pendleton County, VA in 1850.⁶³ Property: listed as owning \$4,000 in real estate in Pendleton County, VA in 1850.⁶³ He signed a will on 25 Feb 1854 in Pendleton County, VA.⁶⁹ He died on 31 Mar 1866; at the age of 89.⁷⁰⁻⁷³ Jacob was buried in Hiner Family Cemetery, Doe Hill area, Highland County, VA.³¹ Family Note: had nine sons and four daughters.⁷⁴ Military: fought in the War of 1812.⁸

6. **John HINER**^{1-2,4,30} (John-1) was born on 21 Feb 1781.⁷⁵ Property: Pendleton County land patent for 76 acres on Bullpasture in 1822.¹²⁵ Property: Pendleton County land patent for 120 acres on Bullpasture in 1833.¹²⁶ Property: Pendleton County land patent for 93 acres on Bullpasture in 1835.¹²⁷ He died on 30 Jun 1851; at the age of 70 in Peru, Miami County, IN.³⁷ Location: moved to Indiana.¹⁻²

7. **Harmon HINER**^{1,4,6,129-134} (John-1) was born on 20 Nov 1782.^{1-2,135-136} He was elected between 1817 and 1819 as Sheriff in Pendleton County, VA.¹³⁷ Property: Pendleton County land patent for 118 acres on Black Thorn in 1818.¹³⁸ Property: Pendleton County land patent for 80 acres on Black Thorn in 1818.¹³⁹ Tithable: Pendleton County, later to become Highland County, VA in 1822.¹⁴⁰ He was elected between 1824 and 1826 as legislator in the General Assembly of Virginia from Pendleton County, VA.¹⁴¹ Harmon was elected between 1829 and 1833 as legislator in the General Assembly of Virginia from Pendleton County, VA.¹⁴² He was elected in 1838 as Sheriff in Pendleton County, VA.¹³⁷ He was elected between 1839 and 1842 as legislator in the General Assembly of Virginia from Pendleton County, VA.¹⁴² Harmon died on 20 Aug 1842; at the age of 59 killed by a falling limb while out salting his cattle in Shenandoah Mountain, VA.^{1-2,6,136,143-145} Location: in Doe Hill area, VA on the Thorn north of Doe Hill.¹⁴⁶ He was buried in Harmon Hiner Cemetery, Pendleton County, WV.¹³⁶

Mariah "Mary" HINER and John BLAGG Sr. were married in 1804.^{75,157,171} **John BLAGG Sr.**^{2,156-157,160,169,171-176}, son of William BLAGG and Elizabeth Jane WILSON, was born on 9 Jun 1778 in Albemarle County, VA.^{157,163-164,169,177-179} Property: 227 & 50 acre tracts purchased from Moses Knapp for \$800 in Pendleton County, VA on 21 Sep 1816.¹⁸⁰ Tithable: Pendleton County, later to become Highland County, VA in 1822.¹⁴⁰ Estate: on 1 Dec 1830 in Pendleton County, VA Paid \$233.33 from estate of Abraham Blagg per his will.¹⁸¹ Property: 120 acre survey with brother James lying on the waters of the Bullpasture River in Pendleton County, VA on 14 Nov 1831.¹⁸² Property: 120 acre Virginia land grant with brother James on the waters of the Bullpasture River adjoining Benjamin McCoy, Abram Blagg, said John Blagg, and the Big Survey in Pendleton County, VA on 9 Nov 1833.¹⁸³ Property: with brother James sold 80 acres on head of Bullpasture to Benjamin McCoy for \$320 in Pendleton County, VA on 6 Nov 1835.¹⁸⁴ Individual Note: in Apr 1839 in Pendleton County, VA member, committee of vigilance.¹⁸⁵ Property: in 1847, 50 acres valued at \$50, 227 acres valued at \$948.86 including buildings valued at \$150, and 40 acres valued at \$40, at the head of the Bullpasture, 12 miles east of the courthouse in Highland County, VA.¹⁸⁶⁻¹⁸⁷ Property: owned 7 horses and 1 clock in 1847.¹⁸⁶ Property: 50 acres being 1/2 of 100 on head of Bullpasture, 8 miles east of courthouse, valued at \$1.00 per acre; tax of \$.05 in Bullpasture River Valley, Highland County, VA in 1848.¹⁷⁶ Property: 227 acres on head of Bullpasture, 8 miles east of courthouse, valued at \$4.18 per acre with buildings valued at \$150; tax of \$.95 in Bullpasture River Valley, Highland County, VA in 1848.¹⁷⁶ Property: 40 acres on head of Bullpasture, 8 miles east of courthouse, valued at \$1.00 per acre; tax of \$.04 in Bullpasture River Valley, Highland County, VA in 1848.¹⁷⁶ Agriculture: in 1850 100 acres improved, 247 acres unimproved land; farm value \$2,000, machinery value \$20, livestock value \$1,000 in Highland County, VA.¹⁸⁸ Occupation: Farmer between 1850 and 1860.^{156,168} Property: Owned real estate valued at \$2,000 in 1850.¹⁵⁶ Property: 50 acres (1/2 of 100), 227 acres, 40 acres, 8 mile east of courthouse in Highland County, VA in 1851-1857.¹⁸⁹ He signed a will on 19 Apr 1856 in Highland County, VA.¹⁹⁰ Property: sold 80 acres of Moses Knapp land and 20 acres of 40 acre patent to Eli H. Wilson for \$200 in Highland County, VA on 6 Jul 1858.¹⁹¹ Property: owned personal estate valued at \$1,193 in 1860.¹⁶⁸ Property: owned real estate valued at \$2,313 in 1860.¹⁶⁸ Property: 217 acres valued at \$1,533 in 1862.¹⁹² He was buried in 1862 in Chestnut Hill Cemetery, Blagg Farm, Doe Hill, VA.¹⁶³ Agriculture: in 1862 owned 9 cattle, horses, or mules valued at \$219.¹⁹² Cash on Hand: \$35 in 1862.¹⁹² John died on 20 Nov 1862; at the age of 84 Smallpox in Doe Hill, VA.^{163,193-194} Estate: in 1866 in Highland County, VA 30 acres, 147 acres, and 20 acres.¹⁹⁵ Estate: in May 1866 in Highland County, VA estate settlement; 185 A to James H., 183 A to Samuel's heirs, and 136 A to John's heirs.¹⁹⁶⁻¹⁹⁷ Estate: on 24 May 1870 in Monterey, Highland County, VA Chancery Court ordered that son James was to pay \$80, with interest compounded, to settle the sale of land made in 1855.¹⁹⁸

Blagg in Highland County, VA on 3 Aug 1889.²⁰⁸ Individual Note: in Jun 1896 in Doe Hill area, VA has never been farther away from home than eight miles; her eight mile trip was to McDowell.²⁰¹ She died on 25 Jun 1903; at the age of 91 after a stroke of

- paralysis two days prior in Doe Hill area, VA.²⁰² Individual Note: never married. She was buried in Chestnut Hill Cemetery, Blagg Farm, Doe Hill, VA.^{202,209}
