Location: in Clover Creek area, Highland County, VA Bullpasture, above Clover Creek about 1752.<sup>1</sup> Property: Bought a farm and mill near Dunkard Church above McDowell from Richard Bodkin Jr. in 1773.<sup>2-3</sup> Property: Pendleton County land patent for 110 acres on Bullpasture in 1799.<sup>4</sup> Property: Pendleton County land patent for 30 acres on Bullpasture in 1800.<sup>5</sup> Property: Pendleton County land patent for 75 acres on Bullpasture in 1800.<sup>6</sup> Property: Pendleton County land patent for 1500 acres on Bullpasture in 1803.<sup>7</sup> Illness: weak in body in Jun 1822.<sup>8</sup> **Joseph MALCOMB**<sup>3,8-10</sup> signed a will on 24 Jun 1822 in Pendleton County, VA.<sup>8</sup> He died in 1822; .<sup>11</sup>

MALCOMB**<sup>8,32-36</sup> (Joseph-1) was born in 1799 in Pendleton County, VA.<sup>34,37-38</sup> Property: Pendleton County land patent for 120 acres in Doe Hill in Doe Hill area, VA in 1832.<sup>39</sup> Occupation: Cooper between 1850 and 1871.<sup>34,37-38</sup> Agriculture: in 1850 30 acres improved, 110 acres unimproved land; farm value \$375, machinery value \$30, livestock value \$225 in Highland County, VA<sup>40</sup> Property: Owned real estate valued at \$375 in 1850.<sup>41</sup> Property: Owned personal estate valued at \$30 in 1860.<sup>34</sup> He died on 9 Jun 1871; at the age of 72 chronic dysentery in Bullpasture River Valley, Highland County, VA.<sup>38</sup>
