weak in body in Jun 1820.²³ He signed a will on 9 Jun 1820 in Pendleton County, VA.²³ He died about 1821; at the age of 62.^{3,27,31} Individual Note: on Pendleton County Grand Jury.³² Military: Revolutionary War soldier.²⁷

John Morgan ARMSTRONG and Agnes Mary "Nancy" ERVINE were married in 1779.^{33–34} **Agnes Mary "Nancy" ERVINE** 19,33,35–40, daughter of Jared ERVINE and Elizabeth, was born in 1764.⁴¹ She died in 1827; at the age of 63.²⁷
