Individual Note: in 1753 Worked on a road from Estill's mill to William Wilson's mill on Bolar Run.<sup>1</sup> Location: Settler on the Bullpasture Valley below Clover Creek in 1756.<sup>2</sup> Tithable: Exempted from head tax in 1766 .<sup>3</sup> **Thomas HICKLIN Sr.**<sup>4-5</sup> signed a will on 7 Sep 1771 in Augusta County, VA.<sup>5</sup> Property: 85 acres, adjoining James Bradshaw in Bullpasture River Valley, Augusta County, VA on 29 Mar 1772.<sup>6</sup> He died in Nov 1772; in Augusta County, VA.<sup>7-8</sup>

Property: 100 acres on a draft of Newfoundland Creek, now called the Bullpasture to James Bratchey for 50 pounds in Bullpasture River Valley, Augusta County, VA on 11 Nov 1766.<sup>9</sup> Property: to Samuel Givens on waters of Newfoundland, known by name of Bulpasture in Augusta County, VA on 20 May 1772.<sup>10</sup> Individual Note: on 13 Apr 1778 in Augusta County, VA signer of a petition to establish a new county.<sup>11</sup> Property: land to Charles Errowin

(Erwin), patented to Hugh on 14 July 1769; in Augusta County, VA on 11 Apr 1780.<sup>12</sup> Property: owns 9 horses and 13 cattle at Cowpasture in Augusta County, VA in 1782.<sup>13</sup> Property: owns 10 horses and 17 cattle in Augusta County, VA in 1787.<sup>14</sup> Family Note: in 1787 one white male between 16 and 21 years in Augusta County, VA.<sup>14</sup> Location: moved to Kentucky about 1797.<sup>15</sup> **Hugh HICKLIN**<sup>5,9,14,16-18</sup> (Thomas-1) was born (date unknown).

Hugh HICKLIN and Elizabeth were married.<sup>9</sup> **Elizabeth**<sup>9</sup> was born (date unknown).

7. Moved to: in Kentucky .<sup>3</sup> **HICKLIN**<sup>3</sup> (Thomas-1) was born (date unknown).

**Lewis TAGGERT**<sup>3</sup> was born (date unknown).

8. Location: in Bullpasture Valley, below Clover Creek in 1756.<sup>19</sup> Individual Note: on 13 Apr 1778 in Augusta County, VA signer of a petition to establish a new county.<sup>20</sup> Property: owns 1 black over 16 years, 11 horses, and 26 cattle in Augusta County, VA in 1787.<sup>21</sup> **John HICKLIN**<sup>4-5,22-23</sup> (Thomas-1) signed a will on 7 Oct 1812 in Bath County, VA.<sup>23</sup> Estate: on 21 Apr 1820 in Bath County, VA inventory: saddle, family Bible, and some other small items .<sup>24</sup> He died in 1820; .<sup>3</sup>
